

Terms of Reference

- e. the policies and strategies to cope with future developments including the delivery and development of the health care services in the HKPIVA's perspective;
- f. the policies in respect of Continuing Professional Development and to implement, monitor and review the Continuing Education System; and
- g. the accreditation of Continuing Education providers and to monitor their performance.

E. Accreditation Committee

Terms of Reference

- a. To provide independent authoritative advice on academic and professional standards in an institution by carrying out accreditation, that is
- b. validating or revalidating any phlebotomy programme for the purpose of registration conducted by the institution; and/or
- c. reviewing the general academic and professional standards of the institution.
- d. To promote good practices of accreditation and quality assurance, and to assist in

maintaining and monitoring academic and professional standards.

- e. To advise the HKPIVA on matters pertaining to accreditation and academic and professional standards.
- f. To carry out such other functions connected with accreditation and evaluation as may be permitted or assigned to the Accreditation Committee by the HKPIVA.
